



The 2019 Hocking Hills Artists and Craftsmen Fall Show will be held at the Hocking Hills Elementary School, 19197 St. Rt. 664 S, Logan, OH 43138. Logan, Ohio is located 50 miles southeast of downtown Columbus and about 25 northwest of Athens.

From SR 33 in Logan, Oh, take the OH-664 exit south. Take OH-664 south 8.7 miles to the Hocking Hills Elementary School. The School will be on the right side (west side) of the OH-664.

Much to our regret, the Hocking Hills Dining Lodge which hosted this show for 44 years, burned down in 2016. Until it is rebuilt, the show will be held at another location.

The Hocking Hills region in southeastern Ohio is a nationally known area of forested sandstone canyons with miles of trails wandering through ferns, wild flowers and lovely waterways.

 - Vendors License number must be provided on this application form.
 - The Hold Harmless Agreement must be signed.
- A check for the exhibitor's fee of \$75. The fee for exhibitors who demonstrate their art or craft during the show is \$65. Fees will be refunded to applicants not selected in this year's show.

Note: Vendors must bring approved extension cords if electricity is needed and must bring their own tent and table for their exhibit.
